At its meeting on May 3-4, 2014, the American Osteopathic Association's Commission on Osteopathic College Accreditation (COCA) reviewed the site visit report for the initial awarding of Accreditation for the William Carey University College of Osteopathic Medicine (WCUCOM), located in Hattiesburg, MS. The site visit was conducted on February 12-14, 2014.

In reviewing the site visit report, the COCA determined that the WCUCOM has completed the Provisional Accreditation phase of its recognition process and advanced to Accreditation. The details of this action have been given to you in a separate correspondence.

The achievement of receiving the initial award of Accreditation status means that, as of May 3, 2014, the William Carey University, parent of WCUCOM, is no longer required to maintain an escrowed reserve account for teach out purposes, and is no longer required to maintain an operating reserve account.

The period of restrictions on the assets in each of these funds that was present during the Preaccreditation and Provisional Accreditation recognition statuses has been completed.
