
I am writing to appeal my current disciplinary status regarding formal complaints submitted with regard to my alleged actions as a student at William Carey University. I have appealed the matter to Vice President of Student Services Brenda Waldrip; however, my appeal was denied. Per the student handbook, page 57, I am requesting that my final appeal be reviewed by William Carey University President Dr. Tommy King.

During the last week of classes, complaints were made alleging that I exhibited "aggressive and threatening behavior toward others." These accusations were neither made at any point in time throughout the year nor have been made against me throughout my academic career. I have a clean record in terms of violent behavior, and I am well-respected by my peers of the university, all of whom will proudly attest to my character. Regarding the allegations, I have never "told a student that he/she would be better off dead" or stated that a student is not "in the know." As the majority of the forensic team will admit, I have offered apologies for conflicts within which I was falsely framed as the aggressor in order to facilitate a positive working environment for the team. These current accusations completely contradict my nature and my character, and they contain no truth. I strongly believe that these accusations are an attempt by certain members of the forensic team to damage my credibility, jeopardize my recently-obtained vice-presidency, and to abuse the judicial policy of William Carey University for personal works.

Because I missed the judicial hearing on Tuesday, 8 May 2012, my refutations to these claims have gone unheeded. Disciplinary dismissal is a severe punishment and, in my opinion, should be reserved for cases lacking doubt. According to *The Red Book*, page 56, disciplinary sanctions are "to redirect inappropriate student behavior toward behavior which will contribute to the social and academic development of the student and the overall well being of the university community." While I assume complete responsibility for my absence from the judicial hearing, I have steadfastly maintained my innocence with regard to accusations of "aggressive and threatening behavior." This punishment in no way contributes to my "social and academic development." Considering my success on the forensic team and the falsehood surrounding these allegations, I believe this punishment to be in no way beneficial to the "overall well being of the university community."

I am formally requesting that my disciplinary dismissal be revoked and that either the complaints against me be dropped or that a subsequent investigation be conducted. If given another opportunity, I am certain that I can disprove and invalidate all accusations against me. I have worked tirelessly toward my degree and have one year remaining at William Carey University. I have worked to keep my name and image clean, and these fallacious tales should hold no bearing against the accomplishments and achievements that I have obtained during my tenure at William Carey University.

## Dear Ms. Waldrop

My name is and I will be a senior next year at William Carey
University. I was humbled to be elected the president of the speech and debate teamfor next
year. Even though this brings me feelings of joy, unfortunately I am coping with a problem we
have been facing for the past two years. I have known since I was in high school,
and his behavior has gotten out of control.

The Student Life Committee made up of faculty and staff will convene on Tuesday, May 8<sup>th</sup> at 10:30 AM to address issues that have been brought to my attention with regard to your actions and behavior toward other students on the William Carey campus. You have exhibited aggressive and threatening behavior toward others who have been in close association with you in class and on the forensic team. This negative behavior and threatening manner have been carried beyond this to other areas such as the cafeteria.

The interviews that I have had with some students mention that you have made statements of hating a student; you have told a student that he/she would be better off dead. You have stated that a student is not "in the know" and never will be; that no one likes her. On several instances, you have acted in an aggressive, threatening manner with regard to body language and movement toward another student as if to harm him/her. You have stated that you are in a rage and that you must get it off your chest before you hurt someone.

This type of intimidation and/or threatening behavior will not be tolerated. Therefore, you are to meet with the committee in room 104 of Lawrence Hall on Tuesday, May 8<sup>th</sup> to address these complaints.

The Student Life Committee met on Tuesday, May 8, 2012 to address formal complaints in which you were involved. After careful review of all information presented, the committee has made the following decision for the office of student services to officiate.

- 1) With the date of this letter, you are subject to disciplinary dismissal.
- 2) Disciplinary dismissal, as stated in *The Red Book*, page 55, is permanent termination of student status.
- 3) You may write a letter of appeal and submit the appeal within 48 hours after receiving notice of this disciplinary sanction. The 48 hours applies to Monday through Friday operation. The letter should be submitted to the Vice President for Student Services.
- 4) The president of the university may hear final appeals and take whatever action he deems to be in the best interest of the university.
- You will need to check in with security in order to conduct any necessary personal business.


